

New rules expand access, set standards for telemedicine in Texas

The Texas Medical Board adopted amendments and additions to its telemedicine rules at its August 2010 meeting. The changes became effective October 17, 2010. The following is a list of frequently asked questions.

What types of telemedicine models are allowed under the rules? In general, two models for telemedicine have been identified, each for a different situation: either from an established medical site or from the patient's home.

Established Medical Site: In the first model, a patient receives care through telemedicine at an "established medical site," such as a hospital or clinic or other

site that has the required medical professionals and equipment. There are no specific limitations on the types of care that a patient may receive at an established site, and both initial visits and follow up visits may be done at this type of site.

At these sites, patient site presenters are available to assist in the interface between the patient and the physician (or PA or APN), who is located at a distant site, and sufficient diagnostic equipment must be available. One exception to the requirement of patient site presenters is that if the health care provided is related to mental

Pain Clinic Update

Houston is the "dark heart" of Texas' growing prescription drug abuse problem, according to the Houston Chronicle, accounting for a quarter of complaints about doctors' suspect prescriptions and one-sixth of the state's 1,900 annual accidental fatal overdoses.

Typically, these are walk-in, cash-only enterprises, located in small, rented spaces that can be opened up and shut down quickly.

The good news is a new law is showing promise as a way to beat back the problem. Texas State Senator Tommy Williams, R-The Woodlands, sponsored and passed a bill last session to increase the oversight of pain management clinics in Texas.

The new law requires that pain clinics be owned by a physician and meet specific standards and be certified by the Texas Medical Board. Pain management clinics must also have a medical director who is on-site 33 percent of the clinic's operating hours.

The new law is easier for the medical board to enforce, and gives police and federal drug authorities additional muscle to pursue criminal penalties. The law is similar to one enacted by Louisiana in the past; in fact, Louisiana's law may have inadvertently pushed the pill mill business into southeast Texas.

Medical Director Joins TMB

The Texas Medical Board has hired a new medical director. Linda Gage-White, M.D., joined the agency in January.

Gage-White, an ear, nose and throat specialist, served on the Louisiana State Board of Medical Examiners from 2002 to 2010 as president, vice-president and as a member of the Licensure Committee and the Board's Malpractice Committee.

"We're very pleased to have someone of this caliber join the agency," said TMB Executive Director Mari Robinson, J.D. "Dr. Gage-White's extensive, relevant experience and her passion for patient safety will help fulfill the Board's

mission of public protection."

A native of Fort Lauderdale, Florida, Gage-White graduated from Duke University and received her medical degree from the University of Miami School of Medicine. Gage-White interned at Mount Sinai Medical Center in Miami and completed her residency in otolaryngology at the University of Iowa Hospital and Clinics.



She has been affiliated with Louisiana State University Health Sciences Center for 25 years and served as LSU Health Shreveport's director of the multidisciplinary cleft lip and palate clinic. She was in private practice for 10 years before accepting her most recent full-time academic appointment in 2000. She is board-certified in otolaryngology and has taken part in charitable medical missions throughout the world.

Dr. Gage-White fills a position vacated by Alan T. Moore, M.D. State law requires that if the agency's executive director is a non-physician, a medical director be hired.

health, a patient site presenter is not required unless patients may be a danger to themselves or others.

At Home: In the second model, patients can access health care via telemedicine (video conferencing with a live feed) from their homes. The basic requirement for an in home evaluation is that the patient must be a pre-existing patient previously seen in person either by the physician or PA with whom the patient is teleconferencing or by another physician who has referred the patient to the physician providing telemedicine care and the referral is documented in the medical record. Once that initial diagnosis is made in person or at an established site, the patient may receive follow-up care for that pre-existing condition via telemedicine in their homes.

In addition to the above, distant site providers can treat pre-existing patients in their homes for new symptoms that appear unrelated to the pre-existing condition based on the following criteria and clarifications:

- Distant site providers may treat patients at home for up to 72 hours as long as the patient is advised to see a physician in a face-to-face visit within 72 hours if the symptoms do not resolve.
- Distant site providers may not provide continuing telemedicine medical services for new symptoms to a patient who is not seen within 72 hours.

The rule intends that for a patient presenting minor symptoms, a provider may prescribe a course of treatment that runs longer than 72 hours, such as a 10 day course of antibiotics or a 30 day course of medication to relieve allergy symptoms. It is intended that this option be used judiciously and within the standard of care. It is not intended that ongoing prescriptions for new diagnoses made from the patient's home would be issued.

A physician may not:

- Make an initial diagnosis of a new patient via telemedicine at a patient's home (or other non-established medical site)

unless the physician has conducted a prior face-to-face initial consultation or the patient has been referred to the distant site provider by a physician who evaluated the patient in-person.

- Provide ongoing medical treatment to a preexisting patient with a new chronic condition unless a physician conducts a timely in-person evaluation after the diagnosis of the new condition.

Finally, the patient being seen via teleconferencing from his or her home must be seen by a treating physician for an in-person evaluation at least once a year and no chronic pain treatment with scheduled drugs may occur through this treatment model.

2. What are some examples of facilities that meet the definition of an "established medical site?" In addition to a hospital or clinic, a site could be a facility such as a nurse's station in a public or private school, a volunteer fire department, an EMS station, a residential or institutional care facility, or even a pharmacy. The key criteria are the availability and presence of:

- a patient site presenter who is a licensed or certified health care professional, such as a nurse, emergency medical technician (EMT), or pharmacist; and
- sufficient technology and medical equipment to allow for an adequate physical evaluation.

The rule also intends that an established site be sufficient in size to accommodate patient privacy and to facilitate the presentation of the patient to the distant site provider.

Any location that meets these requirements will be considered an established site.

3. Is there anything that cannot be an established site? Generally, anyplace that does not meet the requirements in No. 2 is not considered an established site. Additionally, a private home is not considered an established medical site. Hospice facilities and nursing homes are not considered to be private homes.

Physician Assistant Disciplinary Actions

The following actions have been taken by the Texas Physician Assistant Board since its last meeting in November 2010.

Revocation

Holmes, Donald Gene, P.A.-C, Lic. No. PA02171, Livingston

On December 3, 2010, the Board entered a Final Order regarding Donald Gene Holmes, P.A.-C., revoking his physician assistant license based on his imprisonment following a felony conviction, based on a proposal for decision filed by the State Office of Administrative Hearings (SOAH) in Docket. No. 503-10-0658. On December 8, 2009, Mr. Holmes was found guilty of conspiracy to distribute and possess with intent to distribute a schedule III substance, more than 40,000 unites of hydrocodone; he was sentenced to prison for 18 months. Previously, on October 7, 2009, the Texas Medical Board filed a complaint against Mr. Holmes with the State Office of Administrative Hearings. On August 24, 2010, the Board filed an Amended Complaint which included an allegation that Mr. Holmes' license should be revoked due to his felony conviction and incarceration.

Houseman, Thad William, P.A., Lic. No. PA01862, Whitney

On December 3, 2010, the Texas Physician Assistant Board entered a Default Order regarding Thad William Houseman, P.A., revoking Mr. Houseman's physician assistant license. The action was based on Mr. Houseman's failure to respond to a complaint filed by the Board on April 12, 2010, with the State Office of Administrative Hearings (SOAH). The April 2010 complaint alleged that Mr. Houseman failed to carry out the recommendations of his treating psychiatrist as required by a February 2004 Agreed Order; failed to submit reports from his treating physician; treated patients without the required supervision by an on-site physician; tested positive for a prohibited substance; failed to pay for and comply with his drug-screening protocol; and failed to timely respond to communications from Board staff.

Unprofessional Conduct

Barak, Jeshua Jorge, P.A., Lic. No. PA05222, Corpus Christi

On December 3, 2010, the Texas Physician Assistant Board and Jeshua Jorge Barak, P.A., entered into an Agreed Order publicly reprimanding Mr. Barak and requiring Mr. Barak to maintain a logbook, available for inspection, of all prescriptions written by Mr. Barak for controlled substances or dangerous drugs with addictive potential; within one year pass the Medical Jurisprudence Examination given by the Texas Medical Board, within three attempts; complete within one year 16 hours of CME including eight hours in pharmacology and eight hours in medical record-keeping; and pay an administrative penalty of \$10,000 within one year; and provide a copy of this Order to all supervising physicians. The action was based on Mr. Barak's unprofessional conduct likely to deceive or defraud the public, and writing a false or fictitious prescription for a scheduled or dangerous drug.

Bryant, Susan Lea, P.A., Lic. No. PA00905, Dallas

On December 3, 2010, the Texas Physician Assistant Board and Susan Lea Bryant, P.A., entered into an Administrative Agreed Order requiring her to pay an administrative penalty of \$2,000 within 60 days. The action was based on Ms. Bryant's failure to report to the Board her June 2007 arrest for DWI and August 2008 conviction.

Medina, Modesto, P.A.-C., Lic. No. PA01382, Beaumont

On December 3, 2010, the Texas Physician Board and Modesto Medina, P.A.-C., entered into a Mediated Agreed Order requiring Mr. Medina to pass within one year the Physician Assistant Jurisprudence Examination given by the Texas Physician Assistant Board, within three attempts; complete within one year 10 hours of CME in medical record-keeping; complete within one year 10 hours of CME in endocrinology; and pay an administrative penalty of \$1,000 within 180 days. The action was based on Mr. Medina's unprofessional conduct; practice inconsistent with public health and welfare; and failure to use proper diligence in professional practice.

Inadequate Medical Records

Aschberger, Lloyd J., P.A.-C., Lic. No. PA00006, Huntsville

On December 3, 2010, the Texas Physician Assistant Board and Lloyd J. Aschberger, P.A.-C., entered into an Agreed Order requiring Mr. Aschberger to complete within one year eight hours of CME in medical record-keeping. The action is based on Mr. Aschberger's inadequate medical records for one patient.

Curry, Joseph Michael, P.A., Lic. No. PA03334, Huntsville

On December 3, 2010, the Texas Physician Board and Joseph Michael Curry, P.A., entered into an Agreed Order requiring him to complete within one year eight hours of CME in medical record-keeping. The action was based on Mr. Curry's failure to maintain adequate medical records for one patient.

Voluntary Surrender

Palmieri, David Craig, P.A.-C, Lic. No. PA01731, Lufkin

On December 3, 2010, the Texas Physician Assistant Board and David Craig Palmieri, P.A.-C, entered into an Agreed Voluntary Surrender Order in which Mr. Palmieri voluntarily surrendered his license. The action was based on the finding that Mr. Palmieri desires to retire his license and that he suffers from a condition that has affected his ability to practice.

Administrative Penalty ("Fast Track") Orders

Four physician assistants received fast-track orders for minor administrative violations.

Impairment Due to Medical Condition

Wall, Jolena, P.A.-C., Lic. No. PA02300, Denver City

On December 3, 2010, the Texas Physician Assistant Board and Jolena Wall, P.A.-C., entered into an Agreed Order requiring Ms. Wall to annually provide results of a physical examination and evaluation by her treating physician regarding her ability to practice safely as a physician assistant. The action was based on Ms. Wall's having a physical condition which may ultimately impair her ability to safely practice as a physician assistant.

Medical Board Disciplinary Actions

The following disciplinary actions have been taken by the Texas Medical Board since its last meeting in October 2010.

Pain Clinic Certificates Suspended

Spring Wellness Center, Houston

On January 11, 2011, a disciplinary panel of the Texas Medical Board temporarily suspended the Pain Management Clinic Certificate of a Houston pain clinic, Spring Wellness Center, thereby barring it from operating as a pain clinic until further notice. The temporary suspension of the Clinic's pain management certificate (without notice of hearing) was based upon the Board's determination that the continued operation of Spring Wellness Center as a pain management clinic poses a continuing threat to the public welfare. The Board found that the clinic was in violation of state laws that: require a pain clinic to be owned and operated by a medical director who is a physician who practices in Texas with an unrestricted license; require the owner of the clinic to be on-site at least 33 percent of the clinic's operating hours; and require physician assistants to be supervised by a physician.

Temporary Suspension

Ramirez, Araceli, M.D., Lic. No. L3083, Brownsville

On December 22, 2010, a disciplinary panel of the Texas Medical Board temporarily suspended the license of Araceli Ramirez, M.D., of Brownsville after determining that Dr. Ramirez's continuation in the practice of medicine would constitute a continuing threat to the public welfare. The Temporary Suspension Hearing Without Notice took place under the Board's authority, granted by the Medical Practice Act, to suspend or restrict a physician's license without notice when it determines the physician's continuation in practice would constitute a continuing threat to the public welfare and the physician has the opportunity to have a Temporary Suspension Hearing With Notice at least 10 days after notice of the suspension just taken. The suspension is effective immediately. The suspension was based on Dr. Ramirez's inability to practice medicine with reasonable skill and safety due to drug abuse, her impaired status and other violations. In 2006 and 2008 Dr. Ramirez entered into Agreed Orders based on her history of substance abuse. In an interview with a Drug Enforcement Agency officer, Dr. Ramirez admitted to being addicted to Vicodin and Xanax, as well as not being able to safely practice medicine. Dr. Ramirez also admitted to writing false prescriptions for Vicodin and self-administering Vicodin; and to replicating the prescription pad of another physician and forging multiple prescriptions for Xanax. The suspension remains in effect until the Board takes further action.

Shin, David Joseph, M.D., Lic. No. F4523, Houston

On December 7, 2010, a disciplinary panel of the Texas Medical Board entered an order of Temporary Suspension or Restriction of Texas Medical License and Temporary Suspension of Pain Management Clinic Certificate (with Notice of Hearing) against David Joseph Shin, M.D., suspending his medical license as well as his certificate for operating a pain management clinic, after determining that Dr. Shin's continuation in the practice of medicine presents a continuing threat to the public welfare. The suspension follows an October 21, 2010 Temporary Suspension Without Notice, and remains in effect until further board action. The board's action was based on the finding that Dr. Shin owned and operated the Better Life Pain Clinic in Houston, where he employed unlicensed individuals to pose as physicians, without his supervi-

sion or presence, and to meet with patients and provide prescriptions for controlled substances using Dr. Shin's DEA registration number and signature. On October 15, 2010, Dr. Shin was arrested by Harris County Sheriff's deputies and charged with one felony count of engaging in organized criminal activity. On October 26, 2010, the Better Life Pain Clinic resumed operations with a suspended pain management certificate until DEA task force officers executed a search warrant on November 4, 2010. On November 19, 2010, Dr. Shin was indicted in Harris County with a felony count of engaging in organized criminal activity. The suspension is effective immediately.

Ward, Julia Renee, M.D., Lic. No. M5571, Houston

On January 14, 2011, a disciplinary panel of the Texas Medical Board temporarily suspended the medical license of Julia Renee Ward, M.D., Lic. No. M5571, after determining that Dr. Ward's continuation in the practice of medicine presents a continuing threat to the public welfare. The suspension is effective immediately. The Order of Temporary Suspension (Without Notice of Hearing) was based on Dr. Ward's operation of a pain management clinic, Tejas Urgent Care Clinic, without the certification required by law; failure to practice medicine in an acceptable, professional manner; inappropriate prescribing of controlled substances; and unprofessional or dishonorable conduct. The physician has the opportunity to have a Temporary Suspension Hearing With Notice at least 10 days after notice of the suspension just taken.

Temporary Restriction

Atlas, Ruth M., M.D., Lic. No. G7616, Houston

On December 23, 2010, a disciplinary panel of the Texas Medical Board entered an Order of Temporary Restriction against the medical license of Ruth M. Atlas, M.D., barring her from prescribing, administering or refilling controlled substances schedules II, III and IV, until further notice. The Temporary Restriction (With Notice of Hearing) was based upon the Board's determination that Dr. Atlas poses a continuing threat to the public welfare. The Board found that Dr. Atlas failed to comply with guidelines for the use of pain medicines; failed to meet the standard of care in her treatment of a patient; prescribed in a non-therapeutic manner; and prescribed dangerous drugs or controlled substances without establishing a proper physician-patient relationship. The temporary restriction is in effect until the Board takes further action.

Failure to Properly Supervise or Delegate

Arnold, Ingrid, D.O., Lic. No. F6978, Mesquite

On December 15, 2010, the Board and Ingrid Arnold, D.O., entered into an Agreed Order requiring Dr. Arnold to have her practice monitored by another physician for 12 monitoring cycles; complete within one year 16 hours of CME including eight hours in risk management with a focus on office management and eight hours in medical record-keeping; pay an administrative penalty of \$2,000 within 60 days; and pass the Medical Jurisprudence Exam given by the Board, within one year and within three attempts. The action was based on Dr. Arnold's inadequate medical records; her failure to use proper diligence in her professional practice; failure to adequately supervise those under her supervision; and failure to keep adequate records of purchases and disposals of controlled substances.

Cease and Desist

Guzman, Rafael, No License, Houston

On December 8, 2010, the Texas Medical Board entered a Cease and Desist Order regarding Rafael Guzman, ordering him to cease any practice of medicine, or any complimentary or alternative medicine, or any express or implied representation that he is a physician. The action is based on Mr. Guzman's unlawfully engaging in the unlicensed practice of medicine at a location known as Wholistic Health Care in Houston, where he held himself out as a physician board-certified in "medicina alternativa." He oversaw the gathering and testing of bodily fluid samples from a patient, and diagnosed numerous medical concerns.

Phillips, Alberto, No License, Houston

On December 3, 2010, the Board entered a Cease & Desist Order By Default regarding Alberto Phillips, ordering him to cease and desist

any practice as a physician assistant, with any violation of the Order constituting grounds for imposing an administrative penalty of up to \$5,000 for any violation of the Order. On August 12, 2010, the Board filed a complaint with the State Office of Administrative Hearings (SOAH), alleging that Mr. Phillips is not licensed to practice as a physician assistant in Texas; that he used a forged physician assistant license; that he practiced as a physician assistant at Braeswood Family Medical Clinic in Houston in December 2008, and January and February 2009. As a result of Mr. Phillips' failure to file an Answer in the SOAH action all facts alleged were deemed as admitted.

Shevlin, Dan, No License, McKinney

On December 3, 2010, the Texas Medical Board and Dan Shevlin entered into an Agreed Cease and Desist Order, requiring him to immediately cease any practice as a physician assistant, with any violation of the Order constituting grounds for an administrative penalty of up to \$5,000 for any violation of the Order. The action was based on the Board's finding that Mr. Shevlin held himself out as a physician assistant, produced a physician assistant license belonging to another person, and that he had injected one or more persons with Botox or Restylane. Mr. Shevlin denies he engaged in unlicensed practice of medicine and entered into the agreement to avoid the expense and inconvenience of litigation.

Szadolc, Andrew J., No license, Dallas/Fort Worth

On November 23, 2010, the Board entered a Cease and Desist Order against Andrew J. Szadolc, prohibiting Mr. Szadolc from practicing as a physician, or impersonating or identifying himself as a physician. The action was based on the Board's finding that Mr. Szadolc unlawfully engaged in the unlicensed practice of medicine in the Dallas/Fort Worth area; and impersonated a physician in the public domain and represented himself as a physician by using the term "doctor," and used the term "Dr." before his name, and the designation of "M.D." after his name on more than one Internet website and in more than one e-mail. In addition, Mr. Szadolc fabricated an American Medical Association identification and signed a contract with Texas Healthcare Systems, stating that he was a medical doctor, and fraudulently obtained monetary compensation related to the administering of medical care. Mr. Szadolc was indicted by the Rockwall County District Attorney for theft of \$30,000 in 2003 from Texas Healthcare Systems and was subsequently convicted of felony theft. He was sentenced to five years in prison in October 2009, and was paroled in October 2010.

Electronic death records are here to stay

If you are EVER called upon to sign a death certificate, you probably are aware of the Texas law requiring that such certificates be completed electronically. To prepare for such an event, you need to register with the [Texas Department of State Health Services](#) - **ahead of time**. Once the death has occurred, it's too late!

More than 100 physicians found themselves facing disciplinary action from the Texas Medical Board last year for failing to comply with the law. It came to our attention that many doctors were unaware of the lag time between online registration and accessing the system; others had difficulty with the health department's registration process itself.

The Texas Legislature asked the Board to extend the grace period for physicians. The Board dismissed pending disciplinary actions, refunded fines and has extended the grace period for registration through the end of the current Legislative session.

It's important to note that electronic death certification is here to stay. The health department adopted this system because it is faster for all parties involved and it's less susceptible to fraud than paper. Therefore, doctors can take advantage of this new grace period to sign up and work through any glitches with DSHS.
