

TEXAS MEDICAL RADIOLOGIC TECHNOLOGY BOARD

LICENSURE COMMITTEE

MEETING MINUTES

February 10, 2017

The meeting was called to order at 9:50 a.m. by Chair, Jennifer C. Flanagan, MRT. Committee members present were Nicholas M. Beckmann, M.D. and Anthony Jaso.

Carol Waddell, MRT entered the meeting at 10:09 a.m.

Agenda Item 2 - Applicants appearing concerning eligibility.

Applicant #1923 appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Dr. Beckmann moved that the committee recommend to the full Board that the applicant be granted a Medical Radiologic Technologist certificate. Mr. Jaso seconded the motion. All voted in favor. The motion passed.**

Applicant #1931 appeared before the Committee to appeal their referral to the Texas Health Physician's Program (TPHP) due the applicant's criminal history at the November 2016 Board meeting. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Dr Beckmann moved that the applicant's appeal be granted. Further that the applicant be granted a Temporary Limited Medical Radiologic Technologist certificate under a public Agreed Order subject to the following terms and conditions for a period of three years:**

- **Attend Alcohol Anonymous meeting at least 1 time per week.**
- **Submit to an independent medical examination and comply with all recommendations by a board certified psychiatrist approved by the Board.**
- **Enroll in the Texas Medical Board drug/alcohol testing program and comply with all requests for testing.**
- **Shall not seek modification of this order for at least one year.**

This recommendation is due to the applicant's alcohol related criminal history and refusal to submit to evaluation by the Texas Health Physician's Program (TPHP). **Mr. Jaso seconded the motion. All voted in favor. The motion passed.**

Applicant #1961 appeared before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Dr. Beckmann moved that the committee recommend to the full Board that the applicant be granted a Medical Radiologic Technologist certificate. Ms. Waddell seconded the motion. All voted in favor. The motion passed.**

Applicant #1962 appeared with counsel before the Committee on referral by the Executive Director. The applicant presented a brief summary and the Committee members asked questions. Following discussion, **Dr. Beckmann moved that the applicant be granted a Medical Radiologic Technologist certificate, under a non-disciplinary Remedial Plan with the following conditions:**

- **4 hours of continuing medical education in Ethics**
- **120 days to pay the \$500 administrative fee**

This recommendation is based on the applicant's criminal history and practicing without as an unlicensed healthcare provider. **Mr. Jaso seconded the motion. All voted in favor. The motion passed.**

Applicant #1963 was referred to the committee by the Executive Director but failed to appear. Following discussion, Dr. Beckmann moved to defer a determination until such time the applicant appears at the next regularly scheduled Board meeting. **Ms. Waddell seconded the motion. All voted in favor. The motion passed.**

Applicant #1967 was referred to the committee by the Executive Director. But failed to appear. Following discussion, Dr. Beckmann moved to defer a determination until such time the applicant appears at the next regularly scheduled Board meeting. **Ms. Waddell seconded the motion. All voted in favor. The motion passed.**

Agenda Item 3 - Proposed licensure agreed orders or remedial plans offered by the Executive Director. Ms. Johnston reported on **10** remedial plans offered by the Executive Director and accepted by applicants. **Mr. Jaso moved that the 10 remedial plans be approved. Dr. Beckmann seconded. All voted in favor. The motion passed.**

Agenda Item 4 - There being no further business, the meeting was adjourned at **11:00 a.m.**
