

TEXAS STATE BOARD OF ACUPUNCTURE EXAMINERS
LICENSURE COMMITTEE MEETING MINUTES
APRIL 12, 2002

The meeting was called to order at 9:35 a.m. by Chairman, Everett G. Heinze, Jr., M.D. Committee members present were Meng-Sheng Linda Lin, L.Ac. and Pedro (Pete) V. Garcia, Jr. Jennifer Soffer, J.D., Assistant General Counsel; Tim Speer, Manager, Acupuncture/ Physician Assistant Division; and various other staff were also present.

Agenda item #2, Executive Session, was considered.
