Message from the TMB President

Reflecting On 2024 and Looking Ahead



I am pleased to announce that after years of dedicated work, our team has completed a comprehensive review and revision of all agency rules. This state-mandated process ensures that our regulations are not only clear and concise, but also in alignment with state statutes. As a result, we have successfully streamlined the rules, reducing the number

of chapters from 40 to 25, making them more accessible and easier to navigate. This continues to be a work in progress, so we will continue to engage with stakeholders to ensure that we continue to provide the best framework of rules and regulations for our residents in Texas.

Our goal was to enter the 89th Texas Legislative Session with a cleaner and better-organized Texas Administrative Code. Now that the session is underway, we will pause rulemaking activities and await any new legislation that may require further changes or updates to our rules. Once the session concludes, as mentioned above, we will address any remaining issues and engage with stakeholders through additional meetings to gather feedback and ensure continued collaboration.

Although most of the rule review led to basic organizational changes, the Board also took the chance to clarify language in areas where licensees and stakeholders have reported confusion. One such area is the delegation and supervision rules.


Delegation & Supervision

As I have mentioned in previous President's messages, it is critical that practitioners understand what is expected of them in these relationships and it is especially important given the continued growth of certain medical business Please note that due to the comprehensive nature of the review and reorganization, many rules have shifted to different chapters. Furthermore, most statutory language repeated in the rules was eliminated to make them less verbose. This does not mean that any specific regulation has been repealed. TMB licensees are encouraged to carefully re-review all applicable **Texas Medical Board** rules related to their license type. To assist licensees and stakeholders in adapting to the reorganization, Board staff created a **reference chart** outlining where to find various provisions in the revised rules.

models (e.g. Medical Spas and IV Hydration Clinics) where delegation and supervision is heavily, if not exclusively, relied upon to offer services. Your medical license is an extremely valuable commodity, and regardless of the business models that pop up, the basic rules that govern your license continue to exist and be enforced.

Ultimately, it is your responsibility to abide by the rules that govern your license, regardless of what others may tell you.

The Board continues to encounter instances where individuals engaging in these business models either have no physician involvement or inadequate physician involvement. To address these issues, the revised Board rules provide more detailed guidance on what is expected of practitioners in facilities offering medical interventions such as Botox, intravenous (IV) hydration therapy, and other similar services. Remember, these are considered medical procedures or treatments and therefore must be administered by a Texas licensed physician or properly delegated to qualified non-physicians to provide such services while under the physician's delegation and supervision.

It has become apparent to the Board that consumers are demanding more transparency about who is administering and overseeing these treatments. As such the revised rules now require facilities to post the name and TMB license number of the delegating physician in all public areas and treatment rooms. Additionally, all advertising materials must feature the supervising physician's name, and all staff must wear ID showing their name and credentials. The revised rules also ensure that standards for medical spas now apply to all delegated medical acts, including IV Hydration therapy, in that delegating physicians must be trained or familiar with and able to perform these acts to the standard of care.

Ketamine and Office-Based Anesthesia

The Board also sought to clarify its regulation of ketamine treatments. Under the rules, ketamine treatments fall under office-based anesthesia rules. A more robust review of the various therapeutic uses for low-dose ketamine will occur after session which may result in additional rule changes if appropriate.

Caring for Pregnant Women

While not part of the recent rule review process, I would be remiss if I did not take this opportunity to remind our licensees of other rulemaking the TMB engaged in over the past year – namely regarding physician responsibility when caring for pregnant women. This past summer the Board adopted new rules regarding Texas' pro-life laws. These rules specifically address ectopic pregnancy at any location in the body and confirm that procedures to treat this condition are



not abortions. Additionally, the rules provide that when addressing a condition that is or may become emergent in nature, a physician is not required to wait to provide medical care until that mother's life is in immediate danger or her major bodily function is at immediate risk. Physicians must follow the standard of care in mitigating risk posed to a woman's life as well as permanent organ injury. Physicians must use reasonable medical judgement to do what is medically necessary when responding to an active, imminent, or potential medical emergency that places a pregnant woman in danger of death or serious risk of substantial impairment of a major bodily function. Please know that the Board understands that, at times, that may include induced termination of pregnancy.

Corporate Practice of Medicine

Finally, I want to briefly revisit the matter of corporate practice of medicine and make it abundantly clear that corporations, entities or individuals (i.e. non-physicians) are prohibited from practicing medicine. Physicians must be free to use their medical judgment without any interference. Any policies established by a healthcare employer or entity concerning medical decision making must include physician involvement, input and approval. In closing, as we embark on this new year and the new legislative session, we are optimistic about the potential for positive changes that will enhance TMB operations, whether through new appropriations, policy updates, or both. We remain committed to our mission and look forward to working with you in the new year.

Celebrating 15 Years of Supporting The Well-Being of Texas Health Professionals

Physicians and health professionals dedicate their lives to the care and well-being of their patients. However, as humans themselves, they are vulnerable to all the same conditions they treat in their patients. Furthermore, the demands and pressures of working in the medical field can take an added toll on their mental and physical health. Often, between busy schedules with focus on serving patients' needs and concerns about privacy and stigma, healthcare providers struggle to balance their patients' wellbeing with their own. The Texas Physician Health Program (TXPHP) helps them navigate personal challenges while ensuring they remain capable of delivering safe and effective care to their patients. Because in the end, a health professional's own wellbeing is vital to their patients' wellbeing.

What is the Texas Physician Health Program?

Established by the Texas Legislature in 2009, the TXPHP is a confidential, non-disciplinary program separate from the Texas Medical Board designed to support Texas physicians, physician assistants, respiratory care practitioners, medical radiologic technologists, acupuncturists, and other health professionals who are dealing with physical or mental health conditions or issues related to substance use.

The TXPHP provides a supportive pathway for physicians and other healthcare providers to regain their own health and continue practicing, or if they have had to step away from practicing, to safely return to practice. The program helps them avoid facing adverse outcomes or disciplinary actions that could ultimately disrupt their careers.

How the TXPHP Supports Physicians

The TXPHP offers services tailored to meet the individual needs of physicians and other healthcare providers, including:

Confidential Consultation: Health professionals can reach out for a confidential consultation if concerned about their own well-being or a colleague's.

Support for Treatment and Recovery: The TXPHP connects physicians and other healthcare providers to appropriate healthcare providers for expert evaluation or treatment, and to the recovery support best suited for their unique concerns.

Ongoing Accountability: The TXPHP provides monitoring for providers in recovery to ensure appropriate treatment of their condition and maintenance of their fitness to practice.

Advocacy: The TXPHP can provide letters of support, documenting adherence with program monitoring to various licensing boards, credentialing committees, or other parties if requested by a health professional participating in the monitoring program. When referring a colleague, to follow-up on the outcome of the referral, simply ask the health professional to have a letter of compliance sent from the TXPHP.

Education and Resources: The program raises awareness about personal well-being, connecting health professionals to tools for managing stress and preventing burnout.

The Importance of Well-Being

The impact of mental health issues, substance use, or burnout on health professionals can be profound—not only on the health professionals themselves but also on the care provided to patients. Research has shown that health professionals experiencing burnout or mental health struggles are more likely to have lower patient satisfaction, higher rates of medical errors, and compromised decision-making abilities. By providing resources, support, and rehabilitation, the TXPHP helps ensure that Texas health professionals are physically and mentally capable of providing the highest standard of care.



Why it Matters

Personal health is an integral component of patient safety, and by offering a confidential, supportive approach to recovery, the TXPHP reduces the stigma surrounding mental health and addiction issues in the medical profession. Rather than facing immediate disciplinary action, those in the program are given the opportunity to address their challenges in a supportive and non-punitive environment. The TXPHP and TMB



strives to create a safe pathway for licensees to report any impairment they may be living with so that we can ensure they are receiving the proper support to practice with the utmost competency. In fact, the TMB has been recognized as a Wellbeing First Champion for the second consecutive year by the Dr. Lorna Breen Heroes' Foundation for keeping our licensing applications free of intrusive mental health questions and for our continued commitment to communicating to our licensee community about the importance of seeking mental health care

For health professionals struggling with addiction, depression, anxiety, or other conditions, the TXPHP offers a pathway to recovery, helping them restore their health and continue their careers. For the Texas healthcare system, this program is an essential resource in ensuring that health professionals have access to the care and support they need to maintain their personal and professional well-being.

Accessing Services

Texas health professionals in need can access the TXPHP by completing the self-report form found on the **website**. To refer a colleague or inquire about other concerns, they can **email** or phone the TXPHP at (512) 305-7462. When someone makes a third-party referral, the only information they will receive back from the TXPHP is a letter of compliance which can be sent only if the health professional who was referred requests that the letter be sent to the referring party. Whether introduced through self-referral or referred by a colleague, the TXPHP is ready to help ensure any health professional can access the care and support they need.

In Conclusion: A Healthier Workforce for a Healthier Texas

The Texas Physician Health Program represents a pivotal investment in the well-being of health professionals across the state. By providing consultation, referrals, resources, accountability, advocacy, and support for health professionals facing personal challenges, the TXPHP not only safeguards the health of the health professionals themselves but also ensures that Texas patients continue to receive high-quality, compassionate care.



Physician Fingerprinting Renewal Requirement



As part of recent legislation, physicians are required to submit fingerprints prior to having their license renewed unless they were fingerprinted for licensing after January 15, 2018. Please note that this is a one-time requirement; additional fingerprint results will not be required for subsequent renewals.

Licensees are encouraged to begin the process early. If you wish to submit your fingerprints before your renewal period, please e-mail **Registrations** and request instructions for your fingerprint submission, along with the required 6-digit ID number for submitting your fingerprints.

You can complete the fingerprint requirement at any point prior to your license expiration date.

Reminders of the fingerprint requirement will be included in the renewal notice sent out 90 days prior to the licensee's current expiration date. Detailed instructions will be included in the e-mail renewal reminder notices.

Continuing ED Tracking with CE Broker

As a reminder, the Texas Medical Board has partnered with CE Broker, an online continuing education compliance platform, to provide our licensees with an additional tool to help them more easily find, track, and report continuing education coursework.

Currently all physician, respiratory care practitioner, acupuncture, medical radiologic technologist, and acudetox specialist licensees have the option to establish a free, basic account with CE Broker,

TMB will continue to roll-out access to our remaining licensee population on a quarterly basis by license type between now

and June 1, 2025. Licensees will be contacted by TMB when their license type is eligible to create an account with CE Broker. **ADOPTED RULES** Rule Changes Effective January 9, 2025

On Friday, December 13, 2024, the Board voted to adopt revisions to 22 T.A.C., Part 9, Texas Medical Board. The adopted rules are the product of a legislatively mandated rule review and resulted in the reorganization of each chapter in 22 T.A.C., Part 9, Texas Medical Board. The adopted rules were submitted to the Texas Register on Friday, December 20, 2024 and became effective 20 days from the date of submission. The revised 22 T.A.C., Part 9, Texas Medical Board rules were published in the January 10, 2025 edition of the Texas Register.



Case Review Experts Needed



- Active practice
- No history of negative peer review action or license restriction
- Acceptable malpractice history
- Initial board certification by an organization that is a member of the American Board of Medical Specialties, the Bureau of Osteopathic Specialists or the American Board of Oral and Maxillofacial Surgery

Forensic Examinations

Per Texas Occupations Code Sec.156.057, a physician who performs forensic examinations on sexual assault survivors must have basic forensic evidence collection training or the equivalent education. A physician who completes a CME course in forensic evidence collection that meets formal category requirements or is approved or recognized by the Texas Board of Nursing, is considered to have the basic forensic evidence training required by the Health and Safety Code, §323.0045.
