

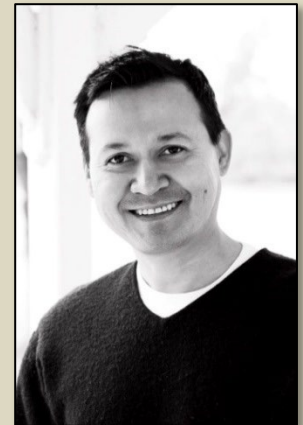
DISTRICT REVIEW COMMITTEE - 1

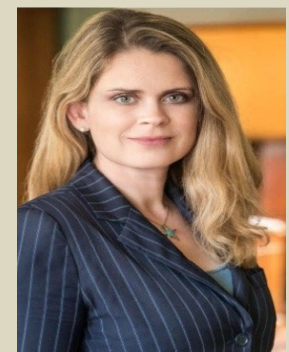
Rajesh G. Shenava, M.D.

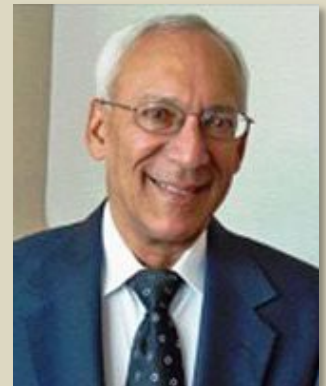
Tejas V. Ozarkar, M.D.

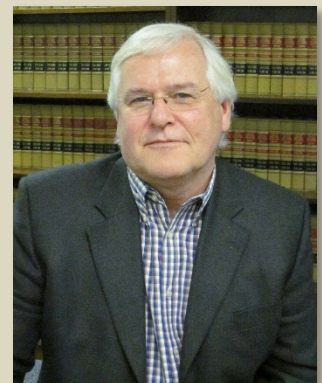
Ivan D. Rovner, M.D.

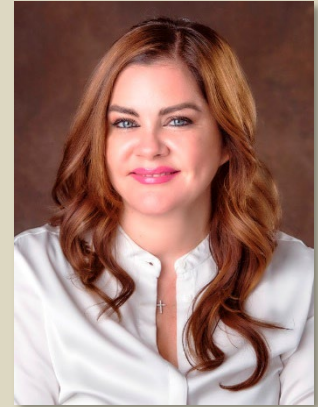


Shirlene J. Samuel, D.O.
