LICENSURE COMMITTEE

MEETING MINUTES

February 7, 2020

The meeting was called to order at 9:55 a.m. by Jennifer C. Flanagan, MRT, Committee Chair. Committee members present were Nicholas M. Beckmann, M.D., and Carol Waddell, MRT.

Committee member absent was Anthony "Tony" Jaso.

Agenda Item 2 - Applicants appearing concerning eligibility.

Applicant #2377 appeared before the Committee to appeal the Executive Director's determination that they be required to complete an additional 3 months under a Supervised Temporary License due their behavior while practicing under an initial 3 month Supervised Temporary License as directed by the out of practice matrix that was approved by the Licensure Committee. Dr. Beckmann moved that the Committee recommend to the full Board that the Applicant's appeal be granted contingent upon the following conditions:

- Applicant shall provide proof of current compliance with continuing education requirements.
- Upon successful completion of this requirement, the Applicant can be issued a general full medical radiologic certificate.

This recommendation is due to the applicant's time out of active practice as a Medical Radiologic Technologist. Ms. Waddell seconded the motion. All voted in favor. The motion passed.

Applicant #2373 appeared before the Committee to appeal the Executive Director's determination of a referral to the Texas Physician Health Program (TPHP). The applicant presented a brief summary and the Committee members asked questions.

Ms. Flanagan moved, and Dr. Beckmann seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Applicant #2373. The motion passed. Ms. Flanagan that the meeting would be closed for deliberations at 10:33 a.m. under the authority of Texas Government Code Chapter 551.071, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any

matter that may be considered or discussed. A certified agenda of any executive session will be made. The executive session ended at 10:52 a.m.

Following discussion, Dr. Beckmann moved that the committee recommend to the full Board that the applicant's appeal be denied and the original determination stands. Further, resolution with the TPHP must be completed within 30 days from this meeting or the applicant will be determined ineligible for licensure. This recommendation is due the applicant's criminal history involving alcohol. Ms. Waddell seconded the motion.

Applicant #2352 failed to appear before the Committee.

Ms. Flanagan moved, and Dr. Beckmann seconded that the Committee close the meeting to the public and continue in Executive Session for deliberations concerning Applicant #2352. The motion passed. Ms. Flanagan that the meeting would be closed for deliberations at 11:01 a.m. under the authority of Texas Government Code Chapter 551.071, and that while in executive session, the Board would not take any action, make any decision, or vote with regard to any matter that may be considered or discussed. A certified agenda of any executive session will be made. The executive session ended at 11:17 a.m.

In open session, Dr. Beckmann moved to determine the applicant ineligible for a license due to ineligibility based on failure to satisfy program requirement hours for a NCT program as reported by the applicant. **Ms. Waddell seconded the motion.** All voted in favor. The motion passed.

Agenda Item 3 - Proposed licensure agreed orders or remedial plans offered by the Executive Director. Ms. Unterborn reported on 1 Agreed Order offered by the Executive Director and accepted by applicant. Dr. Beckmann moved that the 1 Agreed Order be approved. Ms. Waddell seconded. All voted in favor. The motion passed.

Agenda Item 4 – There being no further business, Ms. Waddell moved that the meeting be adjourned. Dr. Beckmann seconded. All voted in favor. The meeting was adjourned at 11:19 a.m.
